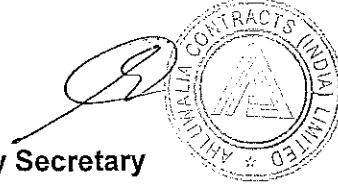

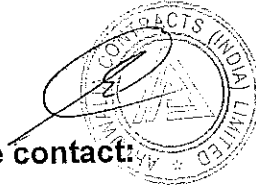
## Recent Award of New Projects worth of Rs. 199.86 Crores
