(IST) and the remote e-Voting platform was blocked thereafter. The votes cast under remote e-Voting facility were then unblocked by me at 06:45 P.M. (IST) on 10<sup>th</sup> February, 2017 in the presence of Ms. Anjali Girotra and Mr. Vimal Chauhan, who are not in the employment of the company.
