# Brief Profile of Mr. Rajendra Prashad Gupta

Mr. Rajendra Prashad Gupta (Independent-Director) aged 70 years has BSC. Civil Engineer from Delhi College of Engineer and has been to his credit more than 46 years of Experience in multifarious activities relating to Indian Railway, infrastructure. He has been involved with Indian Railway Service of Engineers, 1973 Exam. 1st Position in India and Brief Experience on Railways and others sectors as under:

#### 1- Project Planning

- As Additional Member (Works) Railway Board I was responsible for planning of all the major projects of Indian Railways including New Lines, Metro Projects, Doubling, Gauge Conversion etc. Work involved framing policies for project identification, project formulation, surveys, preparation of estimates, obtaining the approval of various authorities including parliament, arranging budget for execution and monitoring of the progress.
- As Director on the Board of Bangalore Metro Rail Corporation Ltd. I participated in the planning, finalization of tenders and monitoring of progress of Bangalore Metro Project.
- As Director (perspective planning) Railway Board, I handled preparation of Annual Plans of Railways, Five year Plans and Corporate Plans in respect Civil Engineering projects.
- As Chief Engineer/Construction, Dy. Chief Engineer /Const. in the field I handled complete planning for execution of major Railway Projects viz; preparation of tender document and tender schedule, Inviting and finalization of tender and execution of work.

- For five years as Director (PSU) Railway Board I was responsible for all administrative matters
  with Ministry concerning IRCON & RITES and other PSUs. This included Analysing their Financial
  and physical performance, Pursuing with various foreign Governments including for obtaining
  contracts and resolving disputes etc.
- As OSD in charge of Dedicated Freight Corridor Company Ltd. I set up the basic organization for implementing the project.
- As Additional Member (Works) Railway Board I was director on the Board of Rail Vikas Nigam Ltd. and Bangalore Metro Corporation Ltd.
- I have completely handled the Railway Amendment Bill for setting up Rail Land Development Authority from cabinet approval to passing in parliament to framing of rules of working to setting up of the authority.

#### 5- Real Estate

- As Advisor( Land ) Railway Board and then as Vice Chairman Rail Land development Authority, I handled following
  - o Identified more than 100 sites of Railway land for commercial development
  - Prepared feasibility reports of more than 70 sites
  - Prepared RFQ documents for selecting the developer for 11 major sites, invited the bids and the completed the evaluation process.
  - Finalised the documents for inviting the financial bid, development agreements and selected the developer.
- Earlier I was responsible for complete management of 4.3 lacs hectare of Railway Land across the country.

<u>6-Construction Management</u>: 16 years of field experience of railway projects execution, Contract Management, Arbitration cases in all capacities from Assistant Engineer to Chief Project Manager.

### **Major Projects handled**

## i) Jammu Udhampur Rail Line:

I was posted as Dy. CE in charge of project at the start remained there for five years. I carried out complete final location survey, coordinated with state government and got set up special land acquisition cell for the project, facilitating acquisition in record time. Set up the project organization, did complete planning and design of important structures including tunnel design in boulder studded rock formation being done for the first time on Indian Railways, finalized the tenders for first block section and supervised the construction.

#### ii) Multistory Buildings

As Dy. Chief Engineer incharge, I executed several Multi storied Residence for Railway Officers at Panchkuia Road from intial planning till finalisation

ii) Rewari Jaipur-Ajmer Gauge Conversion



I was specially picked up ( as Chief Project Manager) for completing the project on the busiest MG line, in a tight time schedule of one year, which at that stage was appearing difficult. I successfully reorganized the whole work and completed it two months before time. For the first time a gauge conversion project was given CRS sanction at full speed immediately after the trial run.

iii) Bhatinda - Suratgarh Gauge Conversion project

I was posted at the beginning of project. This was one of the first gauge conversion projects on IR. I was in charge of one third of the route. This was a Defence priority project. The project was completed in record time of 14 months.

7- Arbitration: During service I had to defend cases of arbitration from Railway side. I also acted as arbitrator in several cases.

I was Sole arbitrator appointed by Supreme Court in one case and by High Court in 3 cases. Award has been published in all the four cases.

Presently I am co-arbitrator in 6 cases appointed by Indian Railways/Jaipur Metro which are in progress.
